

The manual – “A STUDY ON THE MINISTRY OF DELIVERANCE Based on the Manual ‘Can You Administer the Children’s Bread’ by Carol-Ann J Orffer -- has been removed from this website at the insistence of Mrs Orffer and after she threatened to have this website shut down on the grounds of “copyright infringement”

Following is the thread of communication with regard to this material for your information and consideration

I suggest that if you have reached this document because you are trying to contact Mrs Orffer that you pray seriously and earnestly before going further in your attempts to contact her

I published her material because she was not prepared to publish it on the Internet and because I believed it to be extremely important that as many possible were given exposure to it

Mrs Carol-Ann J Orffer initially demanded that I remove it in about October 2012 and I did so

I then created a new website and uploaded the articles from back-up and subsequently realized that I had unintentionally uploaded the material of Mrs Carol-Ann J Orffer again – accordingly I emailed her to reconsider her position

Please read this document to the end

Following is the email that I sent to Mrs Carol-Ann Orffer requesting her to reconsider her position regarding removal of this manual from my website:

Dear Carol

How are you?

I have just set up a new website with a view to improving the global reach of my ministry

In the process I copied material from a backup of my existing website in order to create one consolidated repository of all my material

When I did this I forgot about again removing your material and I only remembered this a few days ago

In locating the extract of your material that you complained about in order to remove it I realized that it was also embedded in a compendium of other items published at the time which is going to require a bit of time and effort to sort out

Before I do this I would like to appeal to you to reconsider your position with regard to the material on my site

While I recognize that you feel possessive about your material and have some reservations with regard to my ministry I would ask you to consider the following:

1. Anything of value in your document is from the Almighty and NOT Carol and therefore is NOT yours to censor or restrict
2. Anything that is just from Carol and NOT from the Almighty is not worth protecting
3. If by having this material on my website even ONE person is reached for good then the purposes of the Almighty with that material have been extended
4. Given that you do NOT have a website and NONE of your material is on the Internet you are being extremely SELFISH in withholding the Almighty's words to Carol from reaching about 1 billion people on the Internet whereas by having the material on my website it is accessible by the leading of the set-apart {holy} Spirit of the Almighty to anyone on the planet with Internet access

Accordingly I would like to appeal to you to reconsider your position and to grant me permission to leave the manual on my new website

I am clear that I am not asking you to endorse my ministry or anything else on the site and I do not ask or expect you to endorse my ministry or agree with me, although I truly believe that what I write is largely given by the Almighty and that I am in close right standing with Him, assisted in significant measure by the ministry that I received from you

In the same way my publication of your material does NOT constitute a blanket endorsement of your ministry – it IS an endorsement of the material that I have published to a point and an endorsement of your ministry as I experienced it in my interactions with you

At that time you were close to our Father and were certainly used by Him as a major instrument for good in my life

Where you are today I have no way of knowing and He has not commented to me, I hope that you are closer to Him today than you were then and that you are continuing to serve Him faithfully, if you are NOT I challenge you to return to Him

I also have a collection of, I think, 15 audio recordings of yours dating from the same period

I have some audio recordings of my own that I hope to publish on my new website shortly and, if you are willing, I would like to publish your audio recordings also, for the same reason – it is better for someone who has no access to an anointed minister to receive some teaching over the Internet than to receive nothing

Accordingly Carol, in the Name of our most High Creator, Yah the eternally self-existing, I appeal to you to grant me permission to leave your deliverance manual on my website and to grant me permission to publish the audio teachings as well

If you refuse this I give you notice that you must recognize that if you are in error in withholding Yah's teachings through Carol from the broader community of believers worldwide, which I hold that you WILL be, you will be deserving of harsh judgment UNLESS you take the trouble to establish your own website and publish this and much more of your material on such website

If you grant me permission I would be willing to publish more of your material should you make it available to me

I look forward to hearing from you ☺

>>> Once I had access to a reliable Internet connection I removed the material – this is the email that I sent to Mrs Carol-Ann J Orffer once I had done that

Dear Carol

I have REMOVED your material from both websites and have ALSO removed the compendium of articles

I have had to drive for half an hour to reach a place with a strong enough 3G signal such that I can do this

I will delete the material from my backups in due course

You will have to refresh your cache in order to see that the documents are NOT there

I am EXTREMELY ANGRY that you have seen fit to threaten my ministry and to threaten to TAKE DOWN MY WEBSITE

I made a sincere mistake

I notified you as soon as I became aware of the problem

I ASKED courteously for you to reconsider your position

YOU respond by THREATENING to shut down my ministry on the Internet!!!!!!!!!!!!!!

I have ALWAYS spoken HIGHLY of you

I have referred a substantial number of people to you

I have received a significant number of inquiries from people who have found your material on my website asking how to contact you and I have immediately given them your contact details
